DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Wiese House, which is located in St. Ferdinand Park, Florissant, Missouri is a one-and one-half storied rectangular, high gabled farmhouse of Germanic inspiration.

EXTERIOR

Overall dimensions

The house measures 38' along its east and west sides and 49' along the north and south.

Construction materials and colors

The house is constructed of soft, red brick, laid in common bond on a random rubble, stone foundation. In addition, all lugsills are of wood. On the south facade an entrance porch is formed by four wooden posts, painted white, which rest on a cement base while supporting a low pitched shed roof. A frame addition for use as a bathroom was added into the original large porch on the northeast corner of the house. This porch is painted white.

Additional features

All windows on the Wiese House, except for those on the frame addition to the north, are topped by segmental arches which are composed of one or two rows of radiating, brick voussoirs. Window styles range from one-over-one light, double-hung sash on the frame addition on the north side of the house to two-over-two light, double-hung sash on the west and north sides, to four-over-four, double-hung sash on the south facade, to six-over-six, double-hung sash on the north, east and west sides.

The main entrance to the house is located in the center of the five-bayed south facade. Its single leaf, four paneled door is topped by a two light, recessed transom. A second, single leaf door is built into the frame addition to the rear.

The roof is high pitched with parapet gables at its east and west sides. Each of these supports two single stack chimneys which are ornamented with brick corbelling at its top. The roof is of wood shingles similar to the original roof.

An additional decorative feature of the Wiese House can be seen in the denticulated, brick frieze which runs along the south facade comprising the cornice just below the gutter.

INTERIOR

The basement does not include the area beneath the wooden porch or rear brick room. This basement has a dirt floor, and is the location of the furnace and a fruit cellar. It can be entered from either the main floor of the house or the back porch.

The first floor of the Wiese House has four rooms grouped around a central hallway. Each of these rooms is furnished with a false fireplace with a plain wooden mantel. Other interior features include molded woodwork around the windows and doors, pine floors and wood-faced ceilings in three rooms. Beyond the central hallway is a masonry wing and formerly a generous open porch which squared off the building.

One large room, which is finished in pine on ceiling and floor, forms the attic of the house.

ALTERATIONS

These include:

- 1. The frame addition on the north side which includes a bath and an enclosed entrance (1922).
- 2. The introduction of plumbing and heating (1922).
- 3. The removal of two, broken-pedimented dormers in 1960 which faced south and which were replaced in 1977.
- 4. The replacement of the original wooden shingle roof with a new wood shingle roof in 1977.

CONDITION

The fabric of the Wiese House is strong and in good condition.

SITE

The Wiese House is located on the eastern side of St. Ferdinand Park. Although it borders a residential area to the east, the Wiese House and its property remain relatively secluded and retain the atmosphere of a farm. This atmosphere is enhanced by the many large trees which surround the building and by the gently sloping terrain. The smoke house with adjoining shed were demolished and a cistern was filled in in 1978.

PRESENT STATUS

On December 19, 1976 the Wiese House was purchased by the City of Florissant to become a part of St. Ferdinand Park. It is currently being restored to its original condition and form by the City of Florissant in cooperation with Historic Florissant, Inc.³

STATEMENT OF SIGNIFICANCE

The Wiese House, St. Ferdinand Park, Florissant, Missouri is locally significant as an example of a Missouri-German Vernacular farmhouse which retains much of its original charm due to its location within a wooded and gently sloping park area.

The Missouri-German Vernacular style of architecture, as defined by Charles van Ravenswaay, is exemplified by a rectangular or "L" shaped brick building, three to seven bays in width, which has a gabled roof. Dormers may or may not be present, and common bond brick patterning is used almost exclusively. In addition, brick is often used to form voussoirs, in the arches which generally cap the windows and doors, and decorative cornices. Windows are seldom ornamented beyond their brick arches or stone or wooden lintels. Doorways are generally capped with glazed transoms, and chimneys are commonly paired and linked by a brick parapet.¹ All of these features are found in the design of the Wiese House.

The Wiese House was built prior to 1870^2 by Henry Bockrath, a German immigrant who became a prominent, local landowner and businessman. In 1873 he built and began operating Hendel's Market in Florissant³, and in 1878 he moved to Jefferson City, Missouri.⁴

The Wiese House was purchased by Henry Kirschburg in 1878^5 and was in turn sold by him to Elizabeth and George Wiese in 1904.⁶ It remained in the Wiese family until December 29, 1976 when it was sold to the City of Florissant.⁷

The survey of Missouri's historic sites is based on the selection of sites as they relate to theme studies in Missouri history as outlined in "Missouri's Historic Preservation Plan". The Wiese House, therefore, is being nominated to the National Register of Historic Places as an example of the theme of "Architecture".










