



# Q1 Improve Highway 21 with turning lanes and install "Caution Vehicle Exiting" light for oncoming traffic.





# Q2 Improve traffic flow in the park with U-turn opportunity, passive parking management, and a dedicated exit lane.





# Q3 Improve parking to accommodate increased visitation, over-sized vehicles, and motorcycles.





### Q4 Increased restroom capacity with new all-season flush restrooms.





## Q5 Install an EV charging station.





# Q6 Update existing Day Use Area to increase ADA accessibility, including sidewalk improvements.







# Q8 Develop new ADA accessible interpretive Area with amphitheater, interpretive kiosks, and a small shelter.












