#### **USE AREAS & DEVELOPMENT**

Finger Lakes State Park's development should emphasize access to recreational opportunities in accordance with land reclamation laws that enabled the park's establishment. Development objectives should support enhancing accessibility and relevance of the park's unique land and water recreational opportunities.

#### 1. Special-Use Camping Area

Designate a Special-Use Camping Area south of the current Youth Riding Area.

#### 2. Special Event Camping Area (Full Hook-Up)

Designate a Special Event Camping Area along the wood-line adjacent to the North Track Restroom – Motocross Track Staging Area. This full hook-up camping area will be developed to accommodate trucks, trailers and their accompanying ORVs.

#### 3. Float-In Camping Area (Basic)

Designate a Float-In Camping Area and construct basic campsites on the main island within Peabody Lake (accessible by water-trail). This amenity will provide a unique and secluded overnight opportunity within the park.

#### 4. North Shore Lake Day-Use Area

Designate a Day-Use Area at the North Shore Lake, which allows paddling, swimming and off-leash dog swimming. Dogs will only be allowed off-leash when in the water while maintaining general park rules once on land (pets must be kept on leashes no longer than 10 feet and under control at all times).

#### 5. Parking Expansion at Park Office

Expand parking at the park's office to accommodate increased visitor traffic and team member needs.

#### 6. Boat Launch Day-Use Area Improvements

Improvements to the Boat Launch Day-Use Area include parking lot expansion, the addition of a vault toilet and development of an ADA accessible fishing dock.

#### 7. Swim Beach Day-Use Area Improvements

Improvements to the Swim Beach Day-Use Area include the addition of a picnic shelter, playground, flush restrooms and multipurpose activity space.

#### 8. Bridge over North Loop Water Trail

Utilize RTP grant funds to construct a new bridge spanning the North Loop Water Trail, providing connectivity for single track riding areas across the northeast portion of the park.

#### TRAILS

#### • Hiking & Biking Only Areas

Designate Hiking and Biking Only Areas surrounding Kelley Branch Creek, within the confines of the ORV trail system, as well as the area between the park office and Peabody Lake.

#### • ORV Trail Expansion

Expand the ORV trail network in the western portion of the park.

#### • Single Track Only Riding Areas

Designate Single Track Only Riding Areas in the northeast portion of the park, between the Swim Beach Day-Use Area and campground.

#### NOTE

• Public Survey #2 proposed redesignating the motocross track for open riding (ATVs/single track only). After review and consideration of public input, this proposed development objective was withdrawn, leaving the track as-is.

#### **PROJECT PHASING**

- Phase 1
  - ORV trail expansion.
  - Float-in campsite construction (basic).
  - Hiking and biking only trail development.
  - Single track only trail development.
  - Bridge over North Loop Water Trail.
- Phase 2
  - Parking expansion at park office.
  - Swim Beach Day-Use Area Improvements.
    - Picnic shelter, playground and flush restrooms.
- Phase 3
  - Special Event Camping Area (full hook-up) construction.
  - Boat Launch Day-Use Area Improvements.
    - Parking expansion, vault toilet and ADA accessible fishing dock.

Cultural and natural resource clearances will be required before on-site modifications and development occur.

#### PLANNING AND RESEARCH GOALS

- Update and/or completion of the park's General Management Plan.
- In-depth ORV trail assessment and education (NOHVCC).

#### **ACQUISITION UNITS**

If offered, acquisition of adjacent property may be pursued only through willing sellers or donors. To be considered, units should enhance the mission of Missouri State Parks through one of the following categories:

- Resource preservation and protection.
- Recreational access and opportunity.
- Management facilitation.


