One and one-half story frame building facing east (ca. 1881). Exterior covered with clapboard siding. House has six rooms. Simple rectangular design under a ridge roof. Facade, three bays wide, is slightly asymmetrical. Structure is devoid of ornamentation except for slight detail on wooden window and door frames. Bay window on south gable end wall first floor. Central brick chimney bisects roof ridge. Windows and doors have vertical proportions in relation to the walls.

House was donated to the State of Missouri by the United Automobile Workers in 1957. Lean-to porch on the front of building was removed. Original, unrestored smoke house and well remain behind the house. House has been furnished in the Victorian style of the 1880's. Restoration was completed in 1959.


