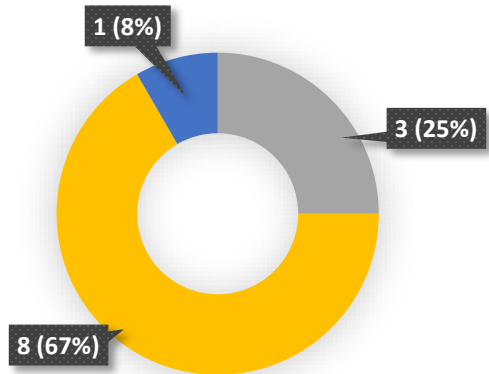
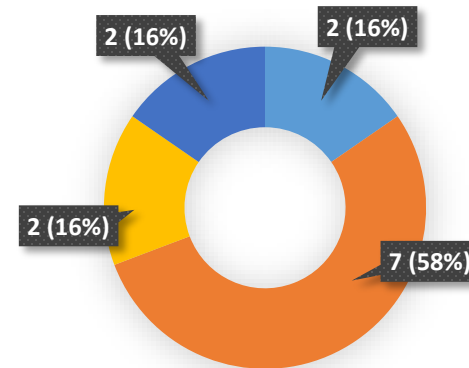


### How often do you visit this historic site?



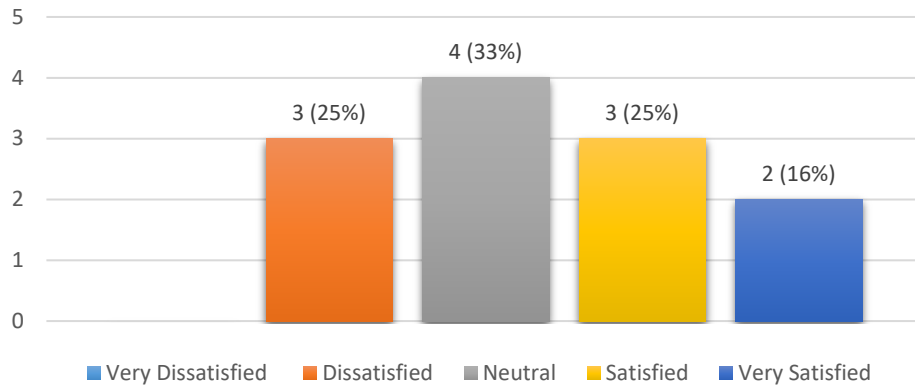

### When you visit this historic site, who usually joins you?



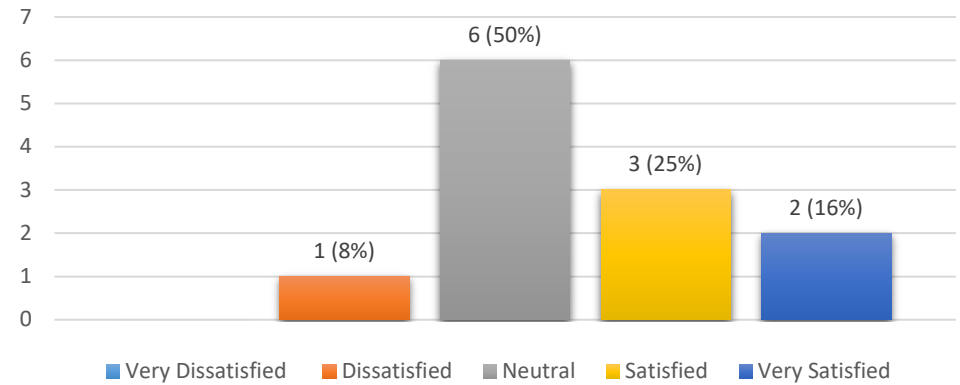

### How satisfied are you with the recreational activities this historic site offers?



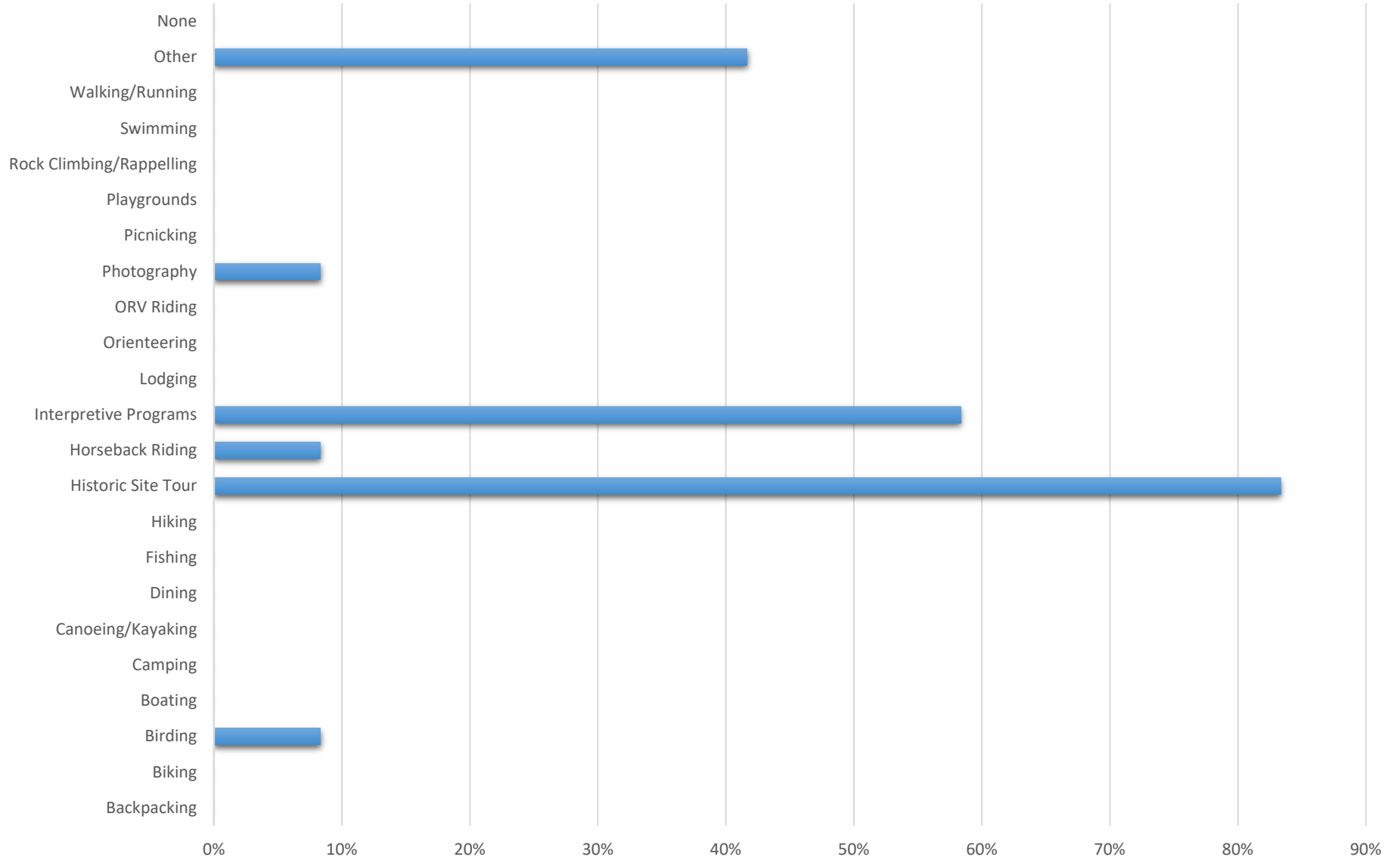
