### Summary

The Leacock Sporting Goods Company Building, located at 921 Locust Street, St. Louis, Missouri is a flat roofed, five-story (historically identified as a four-story plus mezzanine), brown brick commercial building with terra cotta details. Its modest Second Renaissance Revival stylistic façade design is evident in its classical detailing and symmetrical façade with a simple cornice capping the parapet which forms an entablature-like span across the façade. This is supported by the four brick pilasters with terra cotta capitals that separate the upper façade into three symmetrical bays of paired sashed window openings. This colonnaded upper façade rests on top of the storefront that spans both the first floor and original mezzanine level (now called the second floor); this lower level is currently clad in black plastic panels that were added to the building in 1946 when it was remodeled for the Leppert Roos Fur Company (See Figure 23 of the remodeled storefront and Photo 1), but originally the storefront level at the public sidewalk was a wood framed, central recessed entry flanking large plate glass display windows below a tall clearstory transom that spanned the façade with 7 operable hopper windows (See Figure 22 that shows the original façade, although the photograph drastically foreshortens the storefront level). The framework of the clearstory transom and the large cast iron columns nestled into the interior of the display windows at the corners of the recessed entry are still intact as is the sloped floor of the entry (See Photo 5), although currently both are positioned on the interior behind a modern aluminum framed display window system that was built to the height of the original display windows. The original simple projecting cornice was removed (like almost of other downtown buildings because of mandates from code safety officials) but the parapet height and horizontal banding remain. The operable sashes of the original wood windows have been removed, but the decorative mullion separating the paired windows and the original window frames are still intact. The building was constructed in 1917 as the first retail sporting goods store in St. Louis and still retains its distinctive interior retail spaces, with the large open first floor shop floor with its mezzanine at the back and its decorative pressed tin ceiling and decorative structural columns mid-building with its simple open baluster, wooden staircase sandwiched between the freight and passenger elevator.

### Setting

The nominated property is located on a prominent retail street in downtown St. Louis, midblock on the north side of Locust Street between 9<sup>th</sup> and 10<sup>th</sup> Streets, with a twelve-story warehouse building to the east and a two-story commercial building to the west. The adjacent buildings abut the sides of the Leacock building with a public sidewalk south of the building that extends to the façade and a narrow alley that abuts the rear elevation on the north side of the building. Across the alley, a single building which includes a parking garage, occupies the entire block. The area in downtown St. Louis is densely built and dominated by early twentieth century, multi-story commercial buildings, almost all of which are both much taller, but also much wider than the Leacock building. Many of these buildings were originally warehouse or office buildings and most have first floor retail space, including those within the Washington Avenue Historic District, which is directly to the north.

**Front Elevation (Photo 1)**

The front facade is dominated by four brick pilasters with terra cotta capitals and bases that frame the three window bays on the upper three floors (the second floor is actually a mezzanine at the rear and not discernible from the exterior). These visually support the brick frieze and parapet with its original capstones, even though the simple projecting cornice was removed for safety reasons. The upper three floors are symmetrically fenestrated with recessed brick spandrels and with continuous stone sills separating the paired window openings between the pilasters. Recessed diamond patterns in the brickwork of the parapet and the brick outline forming a panel in the spandrels provide additional decorative detailing to the façade. While the glass and sash frames have been removed from the windows, the entire window frame including the jambs and sills is intact. There are three window openings on each floor, which are currently boarded up from the interior, leaving the original wooden window frames visible on the exterior; each of the paired windows is separated by the decorative, recessed panel, wood mullion (currently visible on the exterior in all but one of the nine window openings). The window opening on the right most bay on the third floor is also boarded up from the exterior obscuring the intact mullion and window frame. At the base of the pilasters, there is a continuous terra cotta sill that spans the façade. Below this sill course, the first and second floor of the façade (originally called a mezzanine level since the front portion of the interior is two-stories in height) is covered with what at first appears to be black Carrera glass, but is actually black plastic panels framed around the display windows. The panels are apparently part of the 1946 Leppert Roos storefront renovations to the building (see Figure 23, a circa 1950 photograph which shows the storefront with these black panels and the Leppert Roos neon sign). While the display windows have been boarded over, the original mezzanine level clearstory opening that spans the façade is still intact behind the black plastic tiles and the original storefront level masonry opening is also intact, as are the cast iron columns that define the original central recessed entry. The storefront is currently an aluminum framed display window and door system flush at the sidewalk. There are currently two front entries; the east entry is a recessed entry with full light, paired aluminum doors while the central entry is a single, full light aluminum door with a transom.

The one historic photo (Figure 22) located of the building that dates from its use by Leacock was used in recent investigative work that has exposed the framed clearstory/transom opening that spans above a steel I-beam lintel of the display windows. This opening originally framed a series of seven single light, interior hopper windows spanning as a tall transom between the masonry piers at each edge of the storefront. The photo reveals that originally the building had a recessed central entry flanked by large single pane display windows with four basement level windows framed below the bulkhead below each display window; on the interior, the two original cast iron columns flanking the recessed entry remain intact as does the sloped recessed entry floor (Photo 5 and 7). The historic photo (Figure 22) also shows a band of decorative terra cotta between the storefront transom and the second floor continuous sill, but it is not clear if that terra cotta is still intact behind the black plastic panels which have not yet been removed.

### Side and Rear Elevations

The east side of the building abuts the twelve-story neighboring building and is not visible. Centered on the west elevation (Photo 2), which abuts a two-story building, are four window bays aligned on the fourth and fifth floors with two over two, original, metal sashed windows with segmental arched brick lintels and dressed stone sills. While these windows are all intact, including the wire glass, the fourth floor windows are boarded over on the exterior. There is also a nonhistoric metal trash chute and a metal pipe attached to the west elevation.

Floors two through five on the rear elevation (Photo 3) have four window bays each with paired two over two metal sashed windows, separated by wood mullions, although many have been boarded over and some are missing the glass and have metal security grates. While the upper floor windows have arched brick lintels, the first floor window openings are rectangular and are missing their window sashes. All the windows have stone sills. The inner two bays on the first floor house delivery doors with brick lintels, with paired steel fire doors in the east door opening and concrete block infill in the west opening.

### Interior (Figures 29-33)

All levels of the interior were originally used by Leacock Sporting Goods for both their retail store and warehouse distribution operations which are clearly reflected in the interior layout. The first floor was used as the principal retail sales room (Photo 5) and has 18 foot ceilings to accommodate the mezzanine at the rear (now identified as the second floor) (Photo 4). Like all department stores of the time, the sales floor was divided into separate departments for different sports. The company offices utilized the third floor (Photos 9 and 10), with the fourth floor (Photo 12) used for wholesale operations and the fifth floor used as a warehouse and storage area. The finished basement was also used as part of the retail salesroom. The open floorplates, decorative pressed tin ceilings and cast iron columns found in this building are all characteristic of retail commercial interiors in the early twentieth century.

The first floor of the building (Photo 5, Figure 29) is two stories in height back to the mezzanine which spans across the entire width of the building. The retail space on the first floor is one large open room, extending under the mezzanine (Photo 4) with a small delivery room at the rear of the building and the stair hall (Photo 8), a small passenger elevator (in front of the stairs) and a freight elevator (behind the stairs) positioned along the east wall near the middle of the building. The retail space retains the original pressed tin ceiling (Photo 6), the Doric style cast iron columns down the middle of the building (Photos 4 and 5), and the plaster walls on either side, although the original floor finishes have been covered with carpeting and tile for many years. Across the back portion of the building (Photo 4), the first floor is only one-story in height, with a large wood floored mezzanine level above (Figure 30) that also served as retail space originally.

The upper levels also retain the original open floor plates with the pressed tin ceilings and pressed tin clad central beams on the third and fourth floors (the mezzanine serves as the second floor) (Photos 9, 10 and 12). The third floor has Doric cast iron columns supporting the pressed

tin clad central beam (Photos 9, 10, Figure 31), while the fourth floor has wood posts under the pressed tin clad central beam (Photo 12). The fifth floor is the least finished floor, with exposed brick walls, exposed rafters, and large wood posts supporting the central wood beam and it has no baseboards and the windows are untrimmed (Photo 15 and Figure 33). Even the basement (Figure 28), which was at least partially finished and used as retail floor space for Leacock Sporting Goods, has finished plaster walls on either side and pressed tin ceilings. Much of the basement is not currently easily accessible, but the floor is poured concrete and the front wall is a stacked limestone wall. Windows on the sides and rear are recessed in the plaster walls and never had millwork trim, except for wood stools and aprons but the front windows on the upper levels are framed with a simple mitered corner, flat trim that extends to the baseboards (Photo 14), creating the appearance of a recessed panel between the window aprons and the baseboards. Throughout the building, there are three-member baseboards. Some steam radiators remain, although boxed ductwork has been added.

Besides the pressed tin ceilings and rhythm of window openings on the interior, the most distinctive feature is the straight run, wood staircase with a wood railing enclosed into a narrow stair hall that runs along the east wall with its plaster walls and pressed tin ceilings (including the under sides of the stairs) and wood floors. The staircase has a quarter-turn landing at the first floor (Photo 8) with a wood paneled newel post but starting at the landing above the quarter-turn just four steps above the first floor, the newel posts are simple, “anti-dust” newel posts and the wood railings are simple square balusters. On the third floor the staircase is open into the main room (Photos 10 and 11), but is again enclosed in a stair hall on the fourth floor (Photo 13) and is an enclosed staircase up to the fifth floor.

### Alterations and Integrity Issues

This building is a rare find in downtown St. Louis—it retains the pressed tin ceilings on the first through fourth floors (and in the basement) and it retains the open floorplans that characterized its original use as a retail business on the first floor, mezzanine and basement, with warehouse and distribution offices on the upper levels. Like most commercial storefront buildings, this building has undergone a series of alterations to “update” the retail space and to add more modern amenities (in the form of central air conditioning with exposed boxed ductwork upstairs), as well as changing the storefront level of the façade. It appears the façade alterations, which added the black plastic tiles on the façade was added in 1946 (based upon a major renovation permit issued that year), covered the masonry piers on either side of the display window openings and the clearstory transom to serve as a simple black backdrop for the neon business sign. At the time, this renovation appears to have included a deeply recessed display window and entry (Figure 23) but that was quickly modified in 1956 with the installation of the current aluminum framed display windows that are flush to the sidewalk. The original storefront’s flanking cast iron columns that defined the recessed entry, the sloped entry floor, and the clearstory transom opening that spans the façade with the steel I-beam lintel is still intact and visible from the interior (Photos 5 and 7). In recent years, the first and second floor (mezzanine) have had more alterations, some of which have already been removed in the current renovation

project (modern slat wall coverings, dropped acoustical ceilings, drywall partitions) and the original pressed tin ceilings were found relatively intact although the basement ceilings are badly rusted. At some point after 1984 (when the National Register nomination photos were taken for 917 Locust next door, NR Listed as Scruggs-Vandervoort Barney Warehouse, 2/21/85 ), the simple terra cotta cornice with its paired brackets that rested directly above the stone belt course at the parapet was removed and replaced leaving a simple stone cap, The windows on the west side and rear are the original two over two metal sashed windows, and the façade window frames remain intact along with the decorative recessed panel mullion dividers, but the one over one wood sashes were removed in an aborted rehab project by the prior owner. Despite these alterations, the building is still clearly identifiable as the original Second Renaissance Revival influenced design that housed the Leacock Sporting Goods Company from 1917 through 1946.

### Summary

The Leacock Sporting Goods Company Building, located at 921 Locust Street, St. Louis (Independent City), Missouri is eligible for the National Register of Historic under Criterion A: Commerce at the local level for its role as the first specialty store dedicated to a full line of sporting goods in St. Louis, at a time that the city was becoming known known for its association with sports activities. The five-story Leacock Sporting Goods Company Building was constructed in 1917 by the Sol Abrahams and Sons Construction Company per the designs of architect Nat Abrahams. The building was constructed specifically to house the salesroom, offices and warehouse space of the Leacock Sporting Goods Company, for both its new retail and existing wholesale operations. Prior to the construction of this building, sporting goods, including those distributed by the Leacock Sporting Goods Company were sold either through mail order catalogs or in hardware stores and general stores that would order the goods for their customers. The construction of the Leacock Sporting Goods Company Building represents the changing retail market as specialized sporting goods stores were developed, as well as the increasing commercial importance of athletic products and activities. As the St. Louis economy was maturing, the Leacock Sporting Goods Company was important in the growing athletic goods market. As the first dedicated retail sporting goods company in St. Louis, the Leacock Sporting Goods Company Building is an important physical reminder of the company's role in the growing sports industry and the specialized businesses that developed to supply that industry. The growth of the athletics industry can readily be seen in St. Louis, the home of two major league baseball teams and host of the 1904 Olympics. In addition, amateur sports leagues were growing in popularity (including leagues and teams sponsored by Leacock), Turnverians (German social/athletic societies) and the YMCA being developed throughout the city and other, recreational athletics like cycling, skating, golf, tennis, camping, hiking, hunting and fishing were all becoming common recreational pastimes. The growth of recreational activities as well as the development of amateur and professional sports leagues and organized athletic competitions helped drive the Leacock Sporting Goods Company's move into the retail market and the purpose-built Leacock Sporting Goods Company Building in 1917. The Leacock Sporting Goods Company remained in the building from the time of its construction until the company moved out of the building in 1946, which defines the period of significance for the building as 1917 through 1946.

### Building History

In 1916 the Martin-Briett Real Estate Company entered into an agreement with the Leacock Sporting Goods Company to construct a four-story mercantile building that Leacock would lease for 15 years on a site that had been occupied by a pair of 30 year old two-story buildings.<sup>1</sup> The

building was designed by architect Nat Abrahams “to make it the finest and best equipped store in [sporting goods] west of New York City”<sup>2</sup> and built by the Sol Abrahams and Sons Construction Company.<sup>3</sup> The Leacock Sporting Goods Company had previously been located just a few blocks away at 810 Pine Street (non-extant) but the company had outgrown that location, which it had occupied for 15 years. The Leacock Sporting Goods Company moved “to a location directly opposite the Locust Street entrance to Scruggs Vandervoort & Barney and is considered one of the choicest retail locations in the city”<sup>4</sup> since Scruggs Vandervoort & Barney was one of the largest and most important department stores in the city. The location was also advantageous because it was near the Orpheum Theater and Stadtler Hotel (which would soon open) which created further retail and pedestrian traffic on Locust Street.<sup>5</sup> The building was sold to the Waldheim Company in 1928, but the Leacock Sporting Goods Company remained in the building through March 16, 1946, when it rented space in a building less than a half-block west at 1009-1013 Locust.<sup>6</sup>

In 1946, the building was modernized for the Leppert Roos Fur Company and Dr. George Fisher, an optician, also had offices in the building. The current storefront was installed for the Leppert Roos Fur Company since there is an historic photo (see Figure 23) showing Roos Fur signage on the front of this black plastic veneer that is still on the building today and there is also a photo of the façade that was included in a newspaper advertisement while it was still in use by Leacock Sporting Goods (see Figures 16 and 22) with the original wood framed, recessed entry (very foreshortened in the photo). The Leppert Roos Fur Company left the building by 1956 (the same year that a permit was taken out to alter the building) and Dr. Fisher left the building by 1961 when P. Jackman and Sons, a woolen goods company, occupied the building and remained through at least 1966.<sup>7</sup>

### Leacock Sporting Goods Company History

The Leacock Sporting Goods Company was founded by Robert James Leacock in 1902 as a sporting goods jobbing company.<sup>8</sup> Leacock was born in Illinois in 1863 and moved to St. Louis in 1881. After moving to St. Louis, Leacock first worked as a clerk in a grocery store, then with a sash and door manufacturing company, and later for the Post Office. After leaving the Post Office, Leacock became the manager of the city bicycle and athletic department for the A. F. Shapleigh Hardware Company (a major wholesale hardware company based in St. Louis) from 1896 to 1898. He then became the manager of wholesale bicycle and athletic goods department of the same company until 1902 when he used his experience in sporting goods to form the Leacock Sporting Goods Company.<sup>9</sup> The company was originally located at 808-810 Pine Street [non-extant] and was formed as a jobbing and wholesale company and did not have a retail location when the company was first formed. The Leacock Sporting Goods Company did not initially manufacture its own products (although it would later develop its own branded goods) and acted as a wholesaler and distributor for manufacturers, similar to Robert Leacock's prior experience working for Shapleigh Hardware and their sporting goods business.

When the company was founded in 1902, athletics and sporting goods was a burgeoning field as an increasing middle class had leisure time to engage in athletic activities. People used this leisure time both to play sports and engage in other leisure activities like camping, fishing, hunting, bicycling and driving. People also used the time to watch professional sporting events, as evidenced by the first Davis Cup in 1900, the first World Series in 1903, and the 1904 Olympics, which St. Louis hosted, as well as the growth of college athletic programs. The Leacock Sporting Goods Company supplied the growing demand for athletic and recreational equipment and established a successful business by recognizing the growing demand for these goods.

As the Leacock Sporting Goods Company grew, it expanded its product line to include its own branded products, including golf shoes, uniforms, clothing, fishing equipment, pedal cars and bicycles among other goods, as well as distributing and retailing other companies' goods.<sup>10</sup> The Leacock Sporting Goods Company's product line included equipment for all sports, ranging from team sports like baseball, football, soccer and rugby to individual competitive sports like tennis, golf, bowling and boxing (see Figures 14 and 21). The company also sold other athletic and leisure time equipment like roller skates, ice skates, ping pong tables and equipment, horseshoes, and badminton sets (see Figures 14, 17, 18, and 20). Leacock's product line extended beyond what would be considered sporting goods today to include items that would be found in outdoors

goods stores, including camping equipment, picnic refrigerators and thermos jugs, fishing gear, guns, ammunition and hunting clothes (see Figures 6, 12, 15, 17, and 20). In addition to the hunting clothes, the company also sold uniforms for team sports and even supplied the uniforms for the St. Louis Cardinals when the team won its first World Series in 1926 (see Figure 11).<sup>11</sup> Besides uniforms and hunting clothes, the company also had a wide range of sweaters, sheep-lined and leather coats, sport blouses, jackets, raincoats, boots and shoes for hunting and specific sports (i.e. golf and baseball cleats), and swimsuits (see Figures 6, 10, 13, 14, 19, and 20).

Even before the company moved into the Leacock Sporting Goods Company Building Leacock's product line even extended to automobile accessories, motorcycles and bicycles (see Figures 7, 8, 9), leading the company to join the Motor Accessories Association, an organization that not only consulted each other on a customer's credit but also worked together to notify one another in cases of robberies to help identify stolen goods at a time when many downtown businesses were suffering from repeated break ins.<sup>12</sup> As the company grew, it extended its product line and in 1915 Leacock became the agent for the Miami Motor Bicycle [sic] and was also a contributor to the fund to bring the 1916 presidential conventions to St. Louis.<sup>13</sup> In addition to its sporting goods, the retail store also sold tickets to sporting events like boxing matches at the Odeon Theater, sponsored golf tournaments, and sponsored sports teams from children to adults in municipal and intercity and semi-pro leagues.<sup>14</sup>

In 1916, the Leacock Sporting Goods Company entered a fifteen-year lease to occupy a building that would be constructed especially for the company's use. The company also used the occasion to expand into retail sales, making the Leacock Sporting Goods Company Building the first dedicated retail sporting goods store in St. Louis.<sup>15</sup> Although the forerunner to the Rawlings Manufacturing Company briefly opened a retail store in the 1880s, it burned down less than a year after opening and it was not reopened. Rawlings also had a limited product line only selling equipment and clothing for track, boxing, golf and racquet sports that the company manufactured itself—it was more of an outlet for their manufacturing operations. Even after Rawlings expanded it was mainly a manufacturer and marketed its products through catalogs and other stores rather than having its own retail store operations.<sup>16</sup> In addition, research in city directories

have confirmed that the Leacock Sporting Goods Company's retail location was the first sporting goods retail store in St. Louis. In 1916 as the construction of the Leacock Sporting Goods Company Building began, there were 16 businesses listed under sporting goods, including the Leacock Sporting Goods Company. Of those 16 businesses, Leacock was the only retail sporting goods store. The others included four manufacturers (including Rawlings), two jobbing companies, the wholesale offices of Spalding, a government surplus store, four hardware stores, two mercantile stores, and the Sport Shop, which was the women's outdoor apparel department of Scruggs-Vandervoort-Barney (one of the principal department stores in St. Louis).<sup>17</sup> In 1918 (the next available city directory), two of the hardware stores, the government surplus store and one of the manufacturers were no longer listed while a new hardware store and a fishing and outdoor supply company that also sold baseball, golf and tennis equipment had been added to the listings--Leacock remained as the only retail sporting goods store.<sup>18</sup>

Even after the opening and success of the Leacock Sporting Goods Company's retail store, only 14 dedicated retail sporting goods stores opened during Leacock's occupancy of the building. Of these 14 stores, the first after Leacock Sporting Goods Company to open (both in 1927) were the North Side Sports Shop and the Elmer Lindsey Sporting Goods Store, (both buildings are non-extant). Through the 1930s only four more sporting goods stores were in operation, with the remaining 8 stores opening by 1946. Six more stores opened by 1949, after the period of significance for the Leacock Sporting Goods Building.<sup>19</sup> The Leacock Sporting Goods Company was not only the first retail sporting goods store in St. Louis, but throughout its occupancy of the Leacock Sporting Goods Company Building, it was the leading retail sporting goods store in St. Louis. The growth and development of the business lead others to follow Leacock's lead and open their own retail sporting goods stores, demonstrating the growth of the market and the changing retail environment that allowed for Leacock's success. The development of sporting goods stores demonstrates the growth of the industry as a whole and the growing demand for sporting goods.

The Leacock Sporting Goods Company also used its sponsorship of youth and adult leagues to promote sports and athletic activities while also expanding their customer base. By sponsoring teams, the company not only earned the goodwill of the players, it also created more demand for

the company's products, providing a venue for people to play organized sports rather than having to find enough people for pick-up games.

The Leacock Sporting Goods Company Building was constructed specifically for the Leacock Sporting Goods Company by the Martin-Breft Real Estate Company with a first-floor retail sales room with 18 foot ceilings to accommodate a large mezzanine at the rear of the first floor (now called the second floor although it retains its original dimensions at the back of the building). The sales areas were divided into separate departments for different sports, while the second floor (now called the third floor) was dedicated to company offices, the third floor (now called the fourth floor) to wholesale sales and the fourth floor (now called the fifth floor) was used as a warehouse and a finished basement that was also used as a salesroom while all (except the top) floors had decorative pressed tin ceilings and were accessible by both passenger and freight elevators, as well as dumbwaiters for merchandise.<sup>20</sup> On June 20, 1917 an advertisement in the *St. Louis Post-Dispatch* announced that the Leacock Sporting Goods Company would be holding its grand opening the next day and the ad included prices for many of the company's goods, which included tennis, golf and baseball equipment, swimsuits, auto supplies, camping equipment and bicycles and accessories. The story in the paper the next day described the company's stock of sporting goods and automobile accessories as "one of the largest and most complete in the West."<sup>21</sup> The opening of the Leacock Sporting Goods Company Building represents an important change in the sporting goods industry and the retail environment in St. Louis. By offering a single location for people to purchase all of their sporting goods in person, the company was developing a new model for the market. Customers would be able to try on uniforms and clothes as well as handle the equipment to make sure everything fits the individual, which was not possible with catalog orders. The store also demonstrated to other retailers the viability of specialty stores, as demonstrated by the retail sporting goods stores that opened in the years following the opening of the Leacock Sporting Goods Company's new retail operations.

The Leacock Sporting Goods Company continued to prosper in its new location and became the official distributor of the Racine Rubber Company's tires in 1917. In 1918, it became the distributor for the Security Auto Theft Signal Lock and the H. P. Lindey Company's sporting goods and accessories lines.<sup>22</sup> In addition to the distributorships the Leacock Sporting Goods Company held, they also had signature branded products, including a glove that was endorsed by the St. Louis Browns' first baseman and Hall of Fame player, George Sisler, while Rogers Hornsby, the Cardinals Hall of Famer, is believed to have used a Leacock brand bat.<sup>23</sup> The

Leacock Sporting Goods Company also had exclusive models made by manufacturers including an extensive line of goods from Rawlings while Schwinn designed a beach cruiser bicycle specifically for the Leacock Sporting Goods Company.<sup>24</sup> Throughout the 1920s the Leacock Sporting Goods Company thrived so that when the building was sold in 1927 to Aaron Waldheim, it was believed the purchase was made in large part because of the Leacock Sporting Goods Company's occupancy was "under lease at a substantial rent."<sup>25</sup> Throughout the 1930s and 1940s the Leacock Sporting Goods Company continued to grow, extending its lease in the building in 1935 after the owner promised to make alterations to the building that the newspaper reported as including new windows, a new storefront, electric signs and rearranging the interior.<sup>26</sup> However, there is no evidence that these improvements were ever made for Leacock (see Figures 16, 22). The Leacock Sporting Goods Company remained in the building until 1945, when it moved to a location at 1009-1013 Locust Street,<sup>27</sup> in a building that was remodeled in 1955 with a completely new façade as the Farm and Home Savings and Loan Association (NR Listed for the new façade, 10/29/08). At the time, the Leacock Sporting Goods Company closed its retail operations and moved its wholesale business, which had grown to 85 percent of the company's business, to 22-28 S. 10th Street [non-extant].<sup>28</sup>

### Sporting Goods Industry in St. Louis

Sports and recreational activities became an important industry in the late nineteenth and early twentieth century as growing prosperity granted people more leisure time, they turned to sports and recreational activities as a use of that time. Originally sporting goods were often locally made but as the market grew, a sporting goods industry began to grow, spurred on in large part by the development of professional leagues, especially baseball.<sup>29</sup> The popularity of baseball inspired one professional player, Albert Spalding, to start a sporting goods business with his brother and brother-in-law in 1876 as his playing career was coming to an end. Spalding benefitted from his location in Chicago, where the meat packing industry made the leather needed for gloves and balls readily available while his position as a successful player was a natural way to promote the gloves the company manufactured, and which Albert Spalding used.<sup>30</sup>

Spalding grew quickly and by 1878 was the official supplier of baseballs to the National League, providing proof to other entrepreneurs that there was potential in the sporting goods manufacturing on a national scale. In 1887 George Rawlings and Charles W. Scudder formed a sporting goods manufacturing, wholesale, and retail company in St. Louis.<sup>31</sup>

Despite the nascent development of the sporting goods industry, the products being produced were generally sold through catalogs in general stores or hardware stores. In 1896, city directories only listed three businesses under the heading “Sporting Goods” one of which was a hardware company, another was a firearms store, and nothing could be discovered about the third, which was only listed in the city directory that year (all three are non-extant). Although listings in the “Sporting Goods” listings increased over the years leading to the formation of the Leacock Sporting Goods Company in 1902, there were still only 12 business listed in that category (including Leacock). Of the 12 companies, they included three gun stores, two hardware stores, three manufacturers, and two mercantile companies and another jobber besides Leacock.<sup>32</sup>

### Conclusion

Retail sporting goods stores began to develop in the late nineteenth century but the first sporting goods store in St. Louis was in the Leacock Sporting Goods Company Building, making it an important part of St. Louis’ commercial development. The *St. Louis Post-Dispatch* described the planned opening of the building as a chance for the company to “give St. Louis what it has needed for some time, an exclusive sports outfitting store.”<sup>33</sup> Leacock was able to offer a wide range of sporting goods while offering a way for sporting goods manufacturers to have designated stores to sell their goods, increasing the visibility and the interest in sports and recreational activities by making the equipment more accessible and expanding the St. Louis market by developing a new type of specialty store. The Leacock Sporting Goods Company Building represents the growth of athletic and recreational activities in St. Louis. As more people participated in recreational activities and sports, it created a new market for the equipment related to those pastimes and the Leacock Sporting Goods Company was the first to open a retail location dedicated to that market.

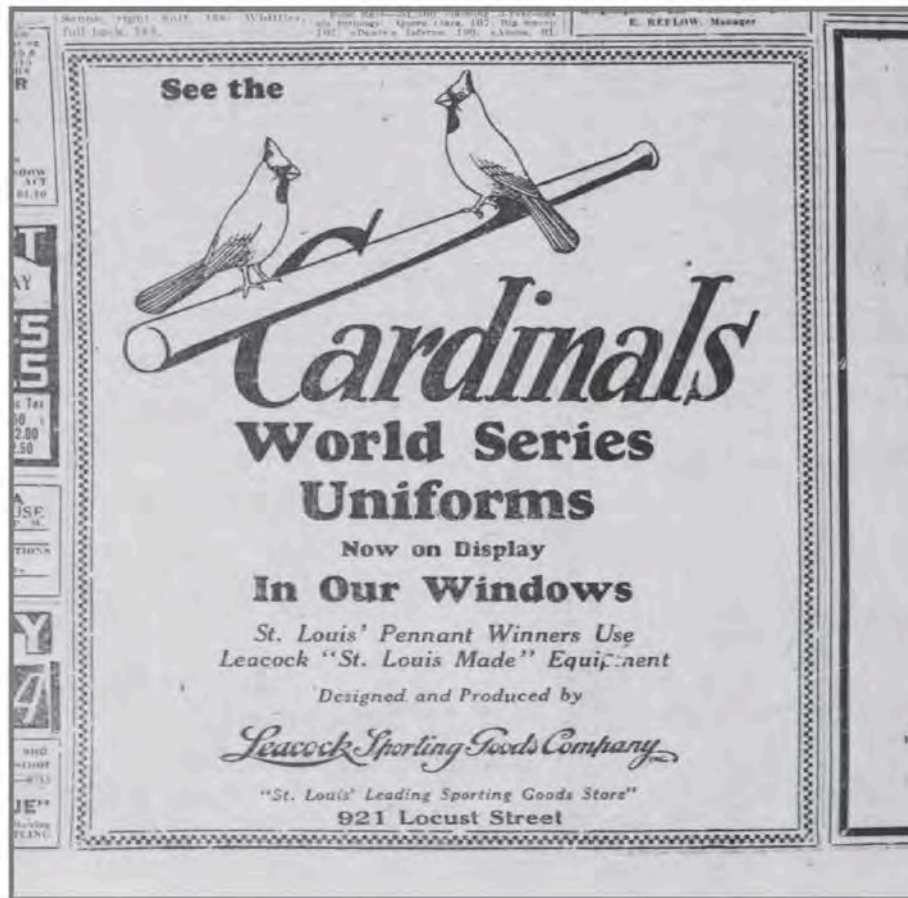
Figure 11: Advertisement

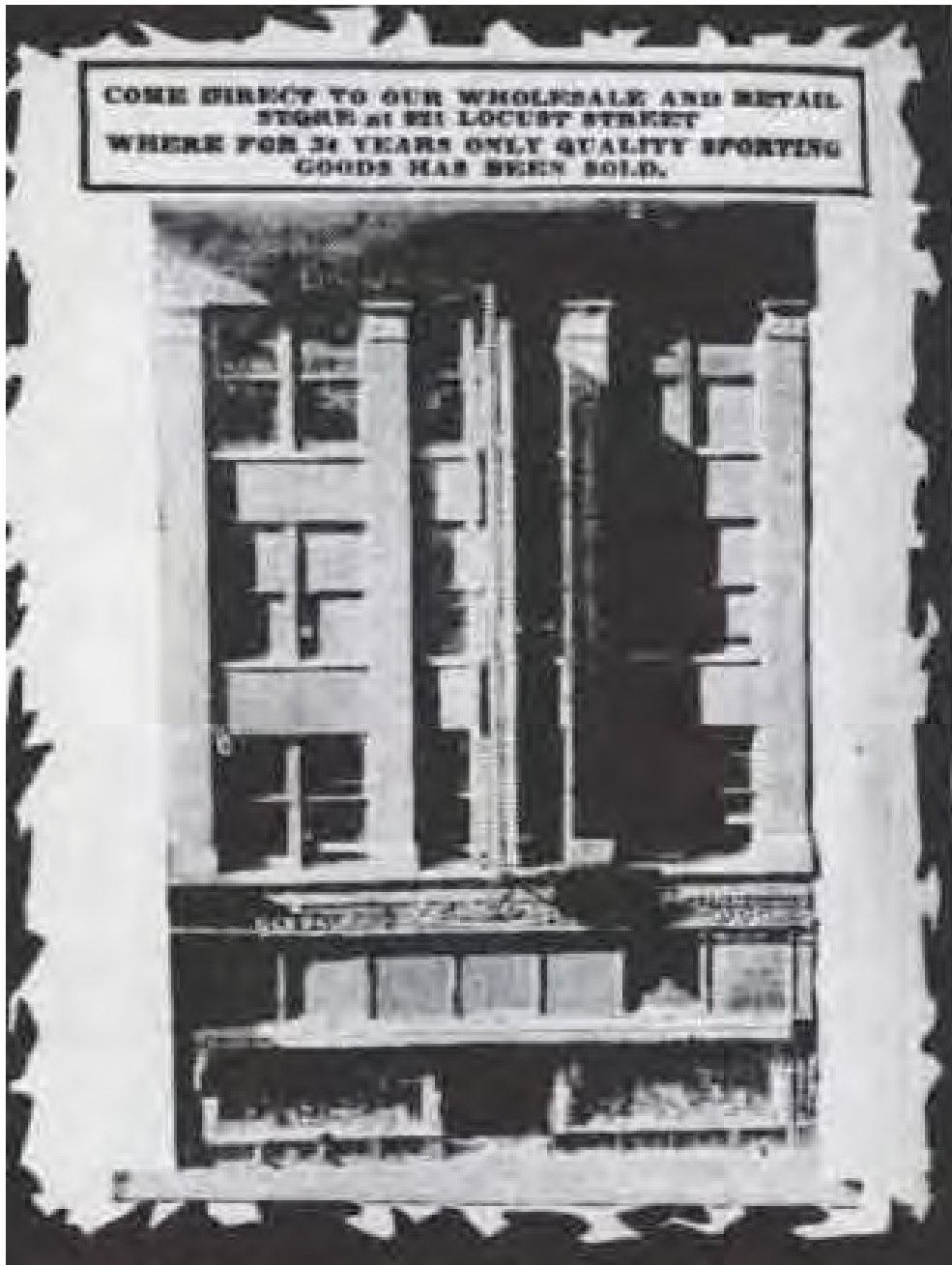

**Figure 23: 923 & 921 Locust ca. 1950**

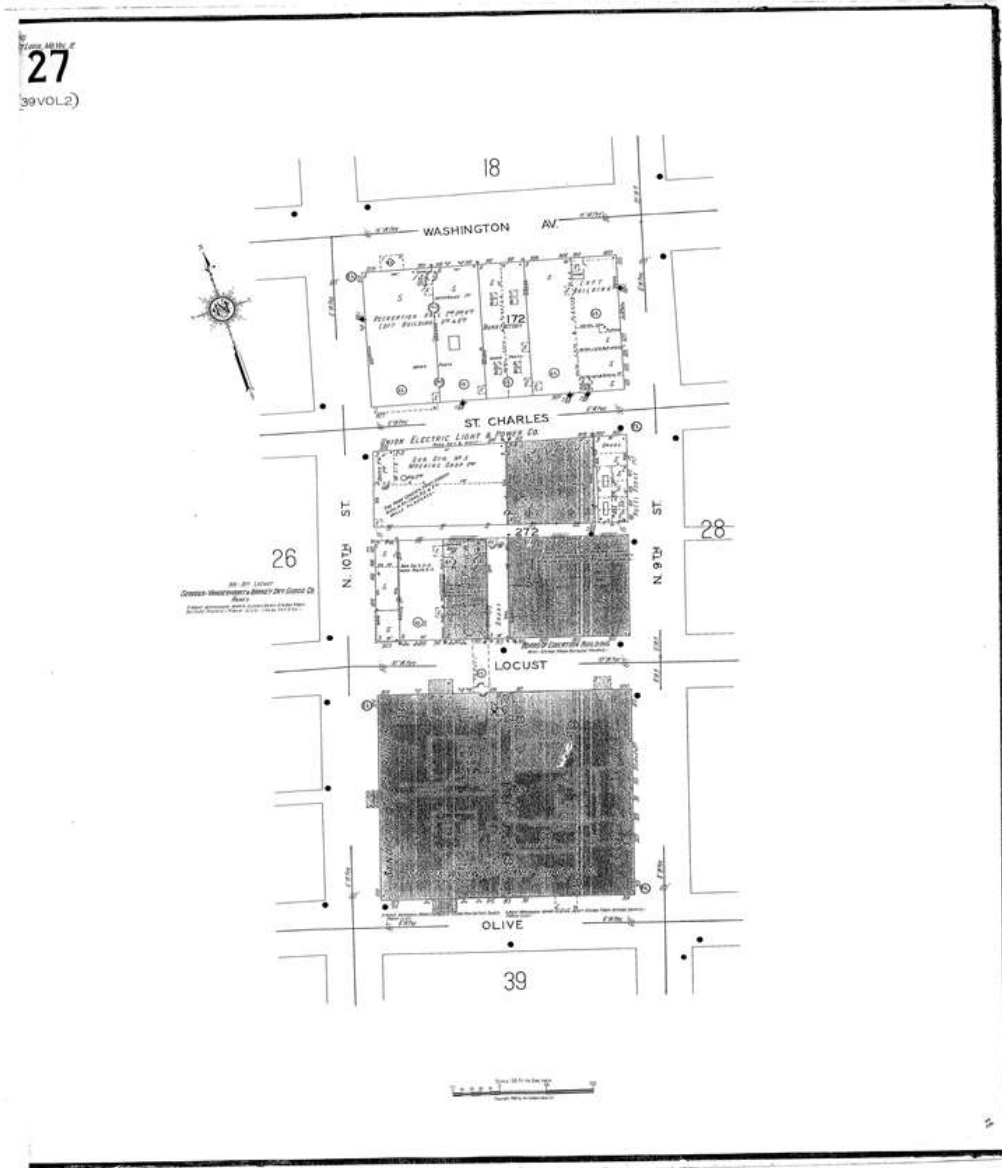

Figure 24: 1932 Sanborn

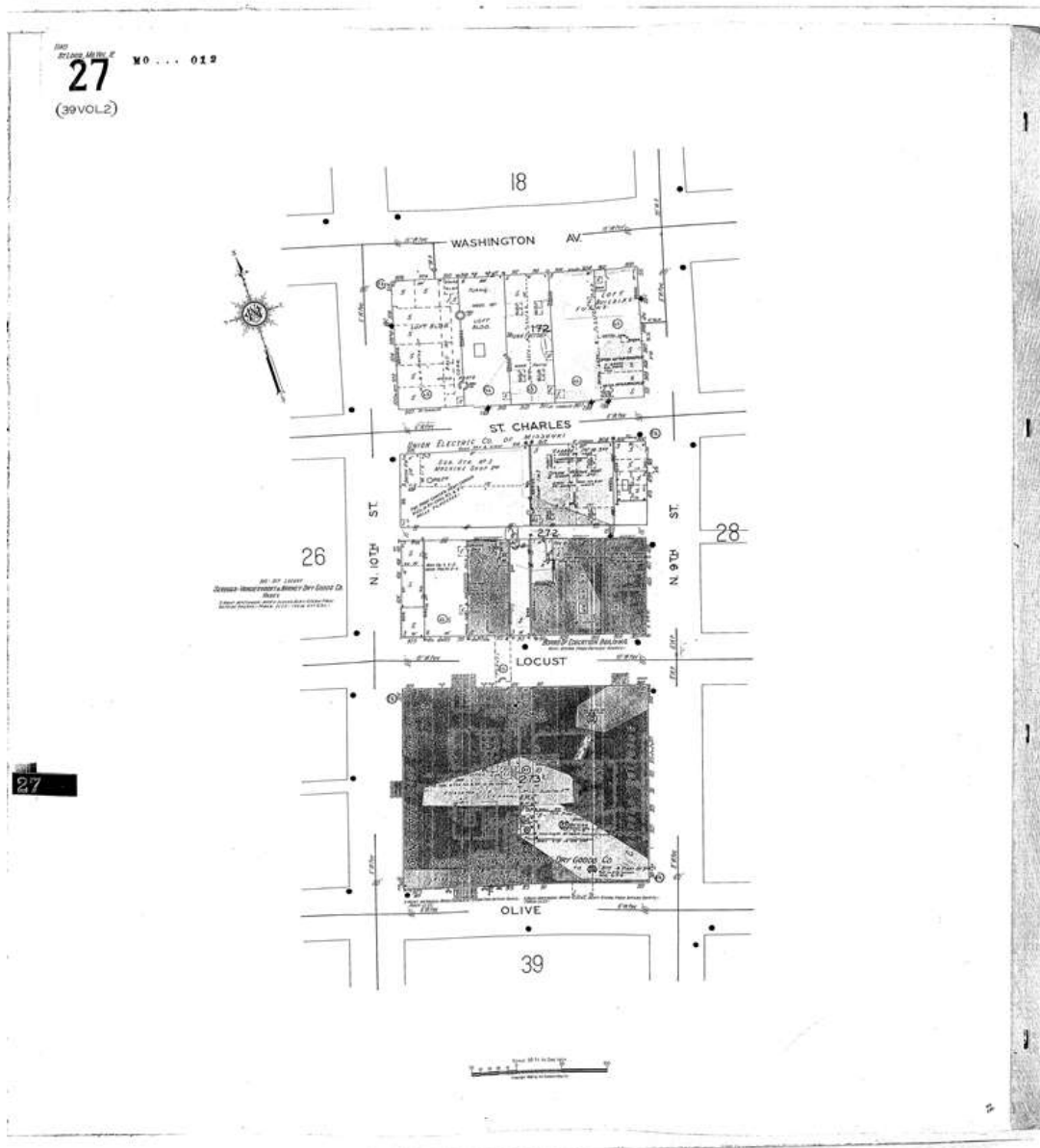

Figure 25: 1951 Sanborn

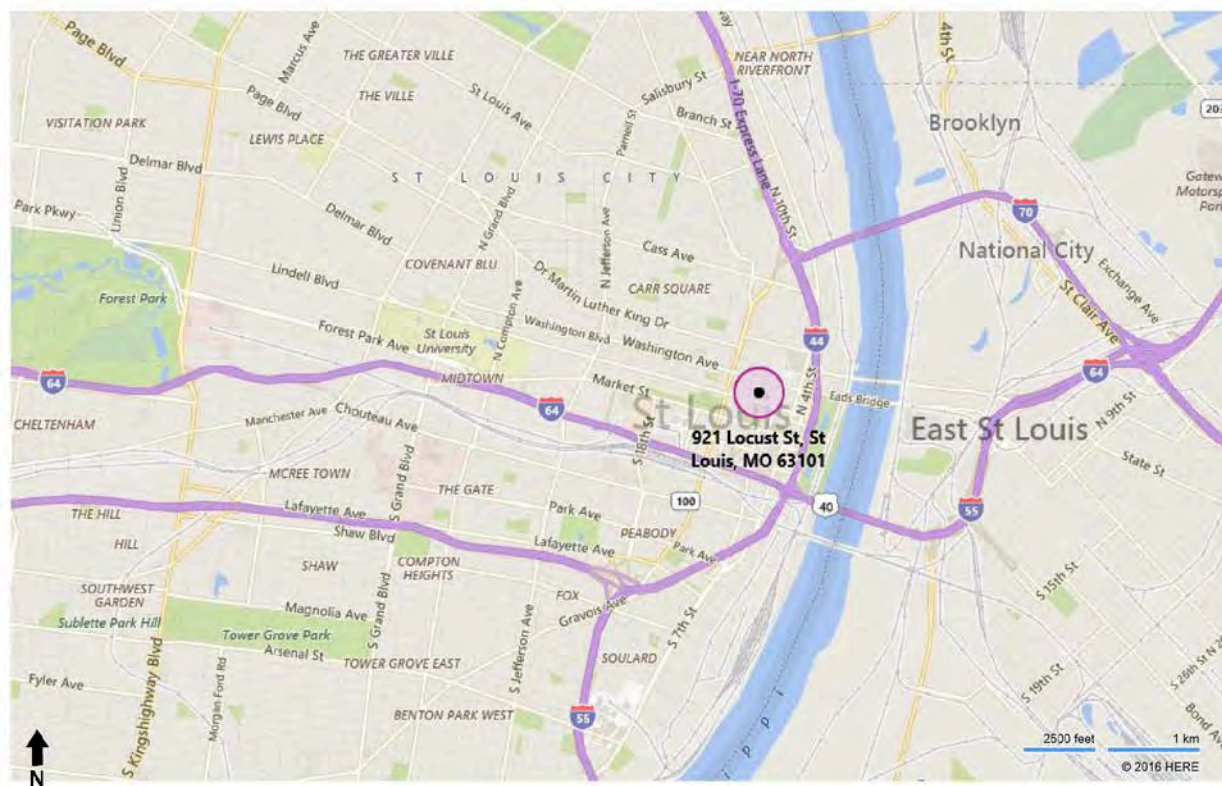

Figure 26: Bing Contextual Map



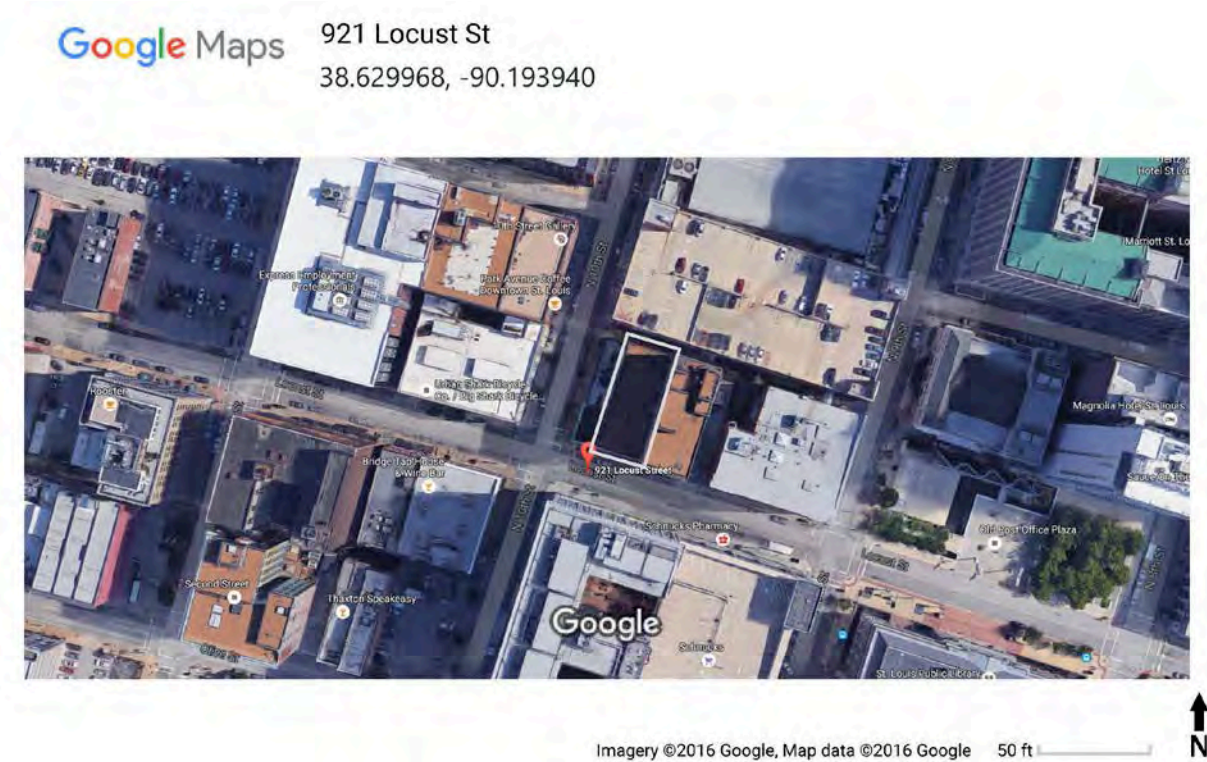

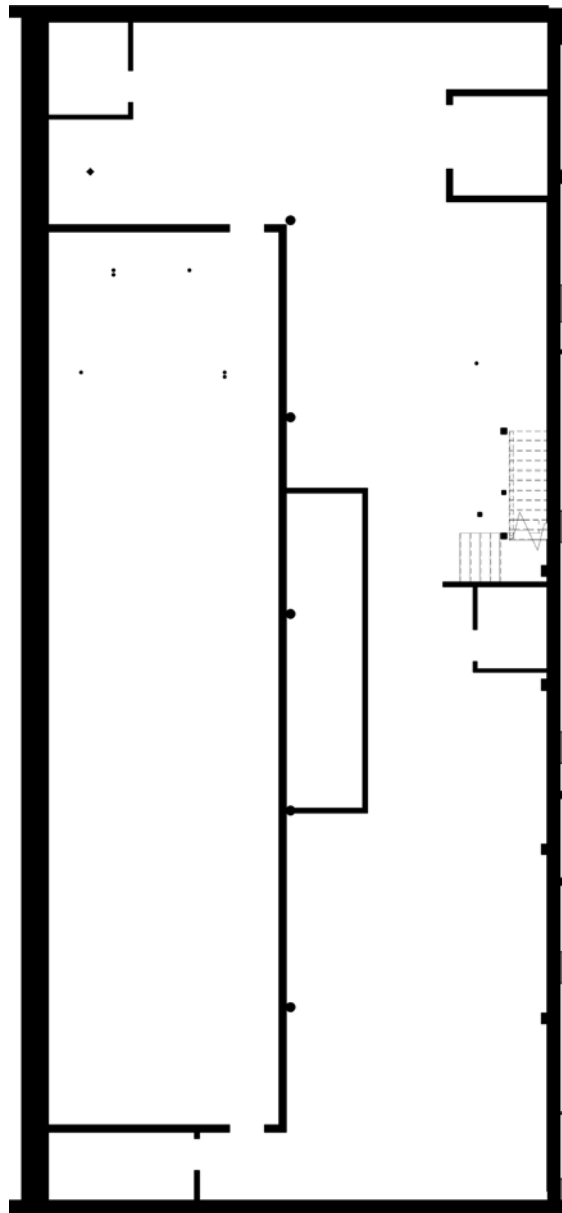

**Figure 28: Current Basement Floor Plan Courtesy of Shiffler Architects PLC Associates**



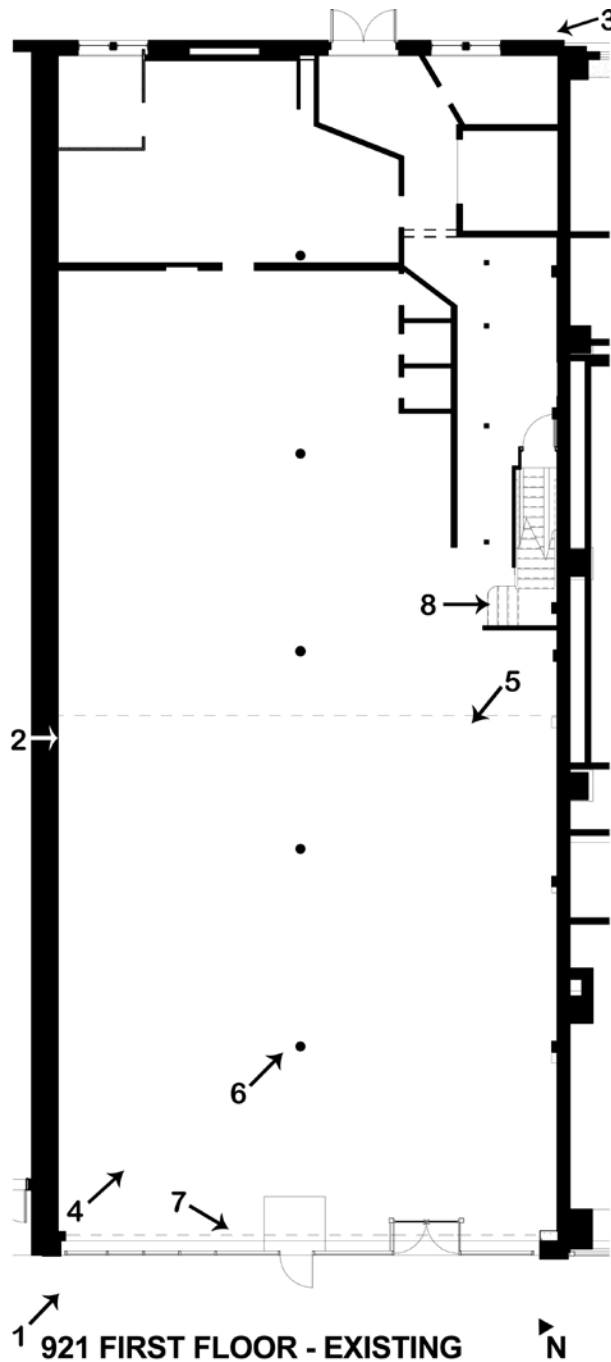
921 BASEMENT - EXISTING

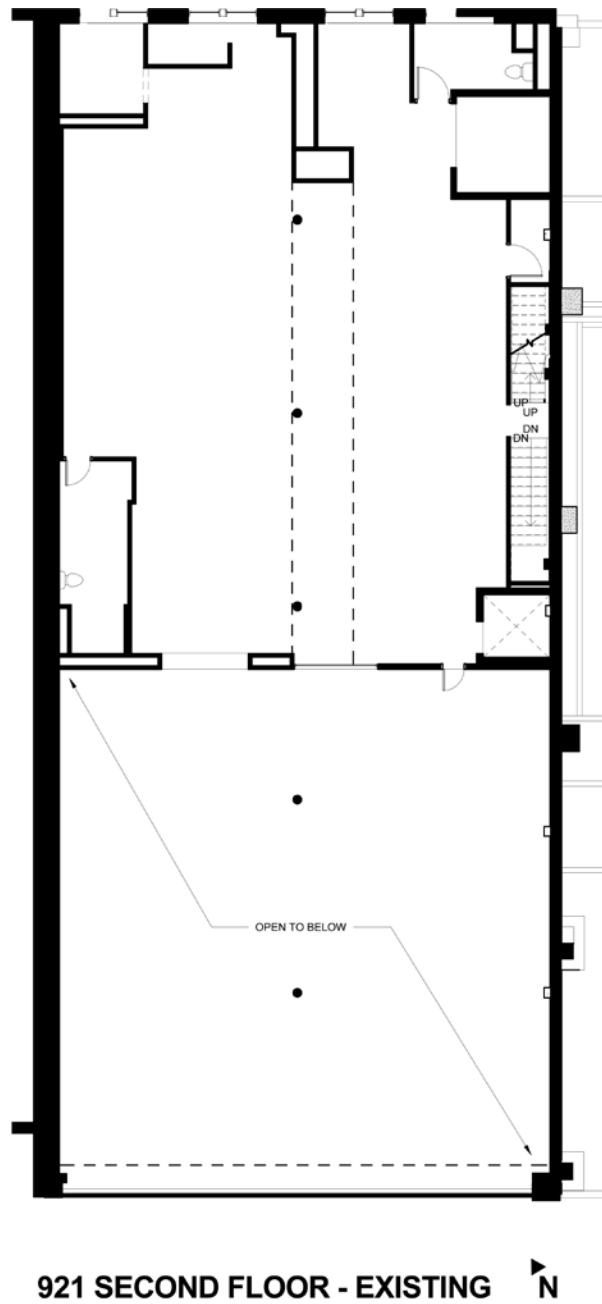

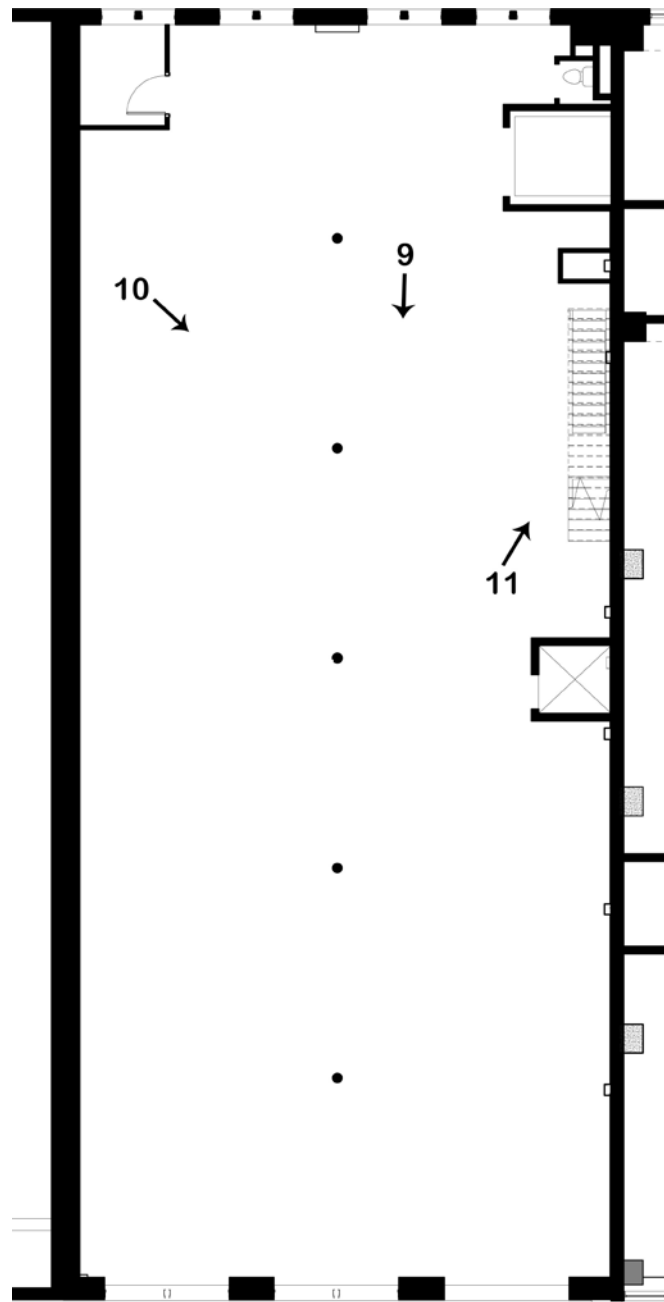

**Figure 31: Current Third Floor Plan Courtesy of Shiffler Architects PLC Associates with Photo Log**



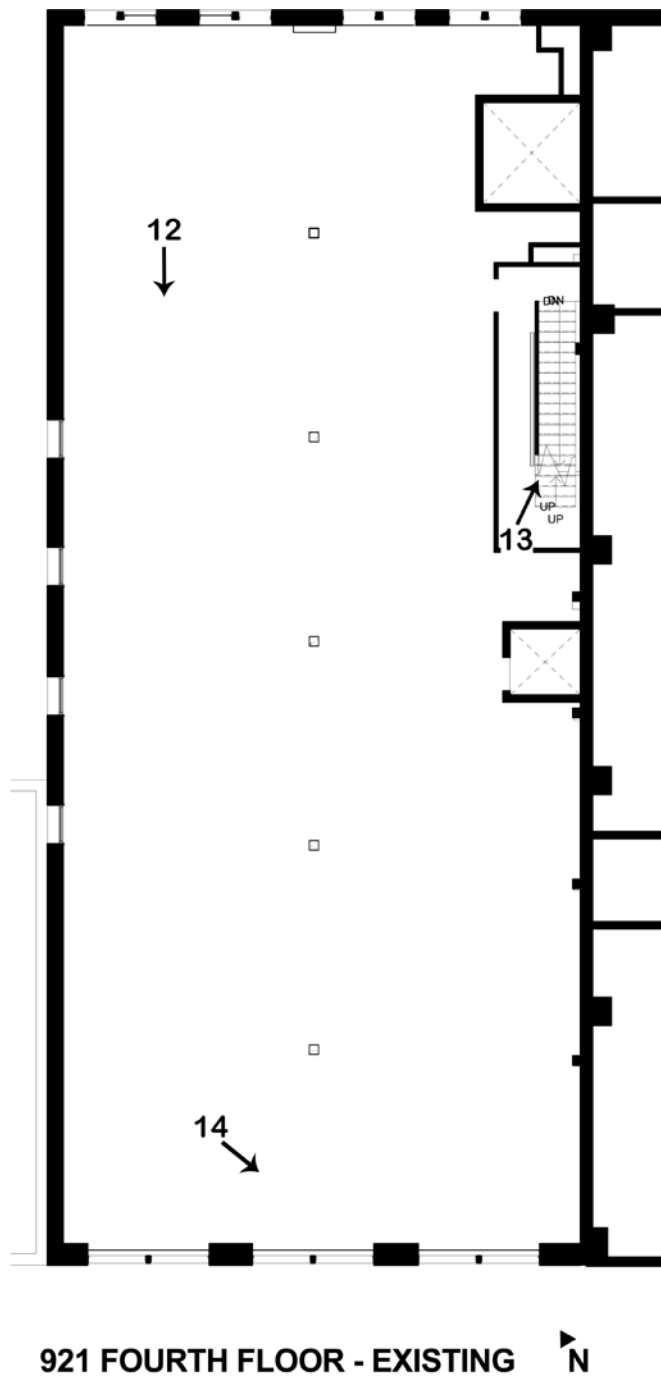
**921 THIRD FLOOR - EXISTING** N

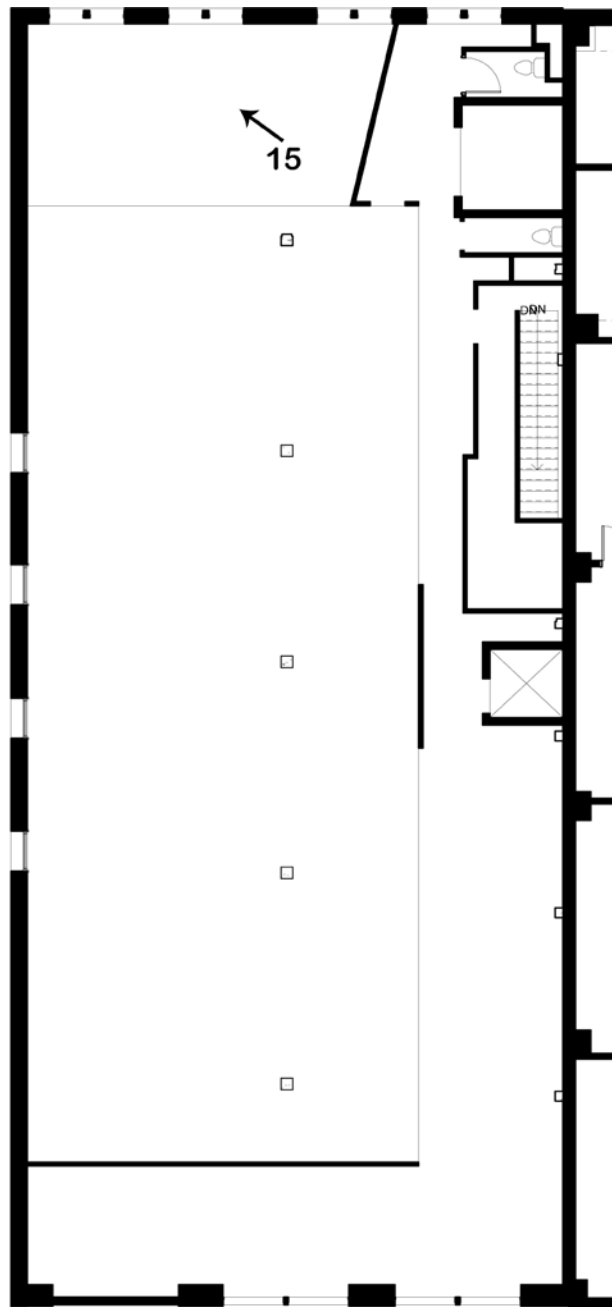
