7. Description, continued.

Summary:

The Jonathan L. Tuepker house is located at 519 Stafford Street in Washington, Franklin County, Missouri. Built circa 1911, it is one and one-half story Narrow Gabled Ell house with a stone foundation, brick walls and a gable roof. It has a three bay asymmetrical facade, arched window and door openings and a Victorian style front porch. The Tuepker house is representative of Property Type E: Gabled Ell, Subtype: Narrow Gabled Ell, and it meets the registration requirements for that property type set forth in MPS Cover document "Historic Resources of Washington, Missouri." The period of significance of circa 1911 is based on the construction date of the house.

The Tuepker house is very much intact and is in excellent condition. The original form and patterns of fenestration are little changed, and the house appears today much as it has throughout its 85 year history. The interior is also very much intact. Much of the original door and window trim, the early or original four panel doors, and the wood floors are in place and in excellent condition. The Tuepker house is the only resource on the property and it is a contributing building. It is one of the more intact Narrow Gabled Ell houses in the study group, and it is a fine example of the blending of a popular twentieth century house form with Victorian and Missouri-German detailing.

Elaboration:

The Jonathan L. Tuepker house is located on west side of Stafford Street between West Fifth and West Sixth Streets in a residential neighborhood. It faces east and sits close to the sidewalk on a gently sloping lot. The houses to the north and south are approximately the same age as the Tuepker house.

The house sits on a stone foundation and has brick walls. The steeply-pitched gable roof is sheathed with cedar shakes, and one of the two chimneys is corbelled. All of the doors and windows are topped with brick segmental arches. The house has an L-shaped plan. The front entrance is located in the front facing gable and the cross gable is located towards the rear of the house. The three-bay facade of the Tuepker house features a side bay entrance and two equally spaced double hung windows. (See Photo No. 1) The one-over-one windows are early or original, but the front door, which is topped by a single light rectangular transom, is a modern replica of the original. The one story hip-roofed porch is one bay wide and has turned wooden posts and a wooden balustrade. It is a modern replacement based on historic photographs. A one-over-one double hung window is centered in the upper gable end.

As a result of the L-shaped footprint of the house, the rear elevation is wider than the front. The first floor of the rear elevation has a door and two windows. (See Photo No 3) The back door, which is directly opposite the front door, is centered on the rear elevation, and it is flanked by one-over-one windows with segmental arched openings. It, like the front door, is topped by a single light transom, and it is sheltered by a central bay porch. The back porch has square wooden posts and a simple wooden balustrade. The porch and the balcony above it are modern replacements. The bulkhead entrance to the basement is also located on the rear elevation. On the second floor, there is a door which leads on to the balcony and a double hung window. The side elevations are basically unadorned. (See Photo Nos 2, 4) Each has equally-spaced double hung windows on the first and second floors.

The interior of the Tuepker house is very much intact and in excellent condition. Throughout the house, the doors and windows retain their original grooved trim and corner blocks, and the original wood floors and four panel doors are in place. The front door opens to a hallway which contains the stairs to the upper floors. The staircase, railing, turned balusters, and newel post are all original. To the north, a door in the side of the hallway leads to the living room; a door at the back leads to the dining room. The kitchen is located in the rear corner of the house opposite the entrance hall. The stairs to the basement are located beneath the stairs to the second floor and are accessed via a door in the space under the stairs to the second floor. The second floor has three bedrooms and one bath. A door in the bedroom above the back door opens out onto the balcony.


Overall, the Tuepker house appears today much as it did when it was constructed circa 1911. It is very much intact, both inside and out, and continues to function, as it has since it was constructed, as a single family dwelling.

Figure One: First Floor Plan. Drawn by Becky Snider.



Summary:

The Jonathan Tuepker house, at 519 Stafford, in Washington, Missouri, is a highly intact Narrow Gabled Ell, and it is typical in plan, massing, materials and detailing of Narrow Gable Ell dwellings in Washington. The house is a representative example of Property Type E: Gabled Ell: Subtype: Narrow Gabled Ell. It meets the registration requirements set forth in MPS cover document "Historic Resources of Washington, Missouri" and falls under the historic context "Architectural Development: 1839-1950. As such, it is significant under Criterion C in the area of ARCHITECTURE...

The house was built circa. 1911 by or for Jonathan Tuepker. The house was sold in 1914 to Anna Bocklage, who owned the house until her death. The house was owned by the Bocklage family for more than three decades. The period of significance of circa 1911 is based on the construction date of the house. The house is the only resource on the property and is a contributing building. The Tuepker house is highly intact, both inside and out, and retains integrity of location, design, setting, materials, workmanship, feeling and association.

Elaboration:

Typical of the Narrow Gabled Ell property type discussed in the MPS cover document, the Tuepker house has a three room L-shaped plan, and it is oriented so that the narrow gabled end is facing the street. It is likely that the house plans were purchased from one of the many architectural pattern book companies; there are several other houses in Washington with very similar plans. The Tuepker house also has brick walls and segmental-arched windows and doors, design elements which reflect Washington's vernacular Missouri-German building traditions. Although most Missouri-German traditions were largely abandoned by the twentieth century in Washington, these features of the building tradition continued to appear on Washington houses well into the 1920s and were particularly prevalent on Narrow Gabled Ell houses in town. Despite the fact that the Victorian styles had largely been superseded by the new National styles after the turn of the century, the Tuepker house also has been embellished with Victorian detailing. The porch, corbelled chimney and interior trim are all Victorian in design.

Around 1910, Jonathan L. Tuepker bought a small parcel of land on Stafford Street from Henry Stegen. Land Tax Assessment books from 1910 show that Tuepker's name was added that year as the owner of the property north of Stegen. The house at 519 Stafford appears to

have been built by or for Tuepker shortly thereafter.² However, Tuepker only owned the house a few years before selling it to Mrs. Anna Bocklage. Anna was the second wife of Henry Bocklage, a German immigrant who moved to Missouri in 1859 and owned a farm in Warren County near Marthasville. According to her step great-grandson, George Bocklage, Anna moved into Washington shortly after Henry died in 1907.³ Although it is unclear how soon after Henry's death Anna moved to Washington, she did not purchase the property on Stafford Street until late 1914 or early 1915. An announcement in the February 13, 1914 Washington Citizen noted that "Jonathan L. Tuepker, who sold his residence on Stafford to Mrs. Anna Bocklage for \$2900, left on Saturday for Boonville to look at some real estate with the view of buying." Anna Bocklage lived in the house on Stafford until her death in 1930; the property was then owned by her daughter Celia Vogt into the 1940s.

The Jonathan L. Tuepker house is an excellent example of the Narrow Gabled Ell subtype in Washington, a popular twentieth century house form which was often given Victorian detailing. It also demonstrates the endurance of Missouri-German building traditions in Washington. It is very much intact and is in excellent condition.



Figure Three: Photo Key Map - First Floor. Drawn by Becky Snider.








Figure Four: Photo Key Map - Second Floor. Drawn by Becky Snider.








