#### What is a CLG?




"Certified Local Governments (CLG) are municipalities [and counties] that have demonstrated, through a certification process, a commitment to local preservation and saving the past for future generations."

#### Certified Local Governments (CLG)

- CLGs must:






#### National Register

- Eligibility for grants/historic tax credits

# Heights Fairview A


#### Local Landmarks


Reduce, reuse, reclaim.

#### BROADWAY THEATRE – 805 BROADWAY




In its heyday, the Broadway Theatre was associated with both 20<sup>th</sup> Century Fox and Paramount Pictures. It originally opened with a showing of the motion picture *The Sheik*, starring Rudolph Valentino. It was first-rate, with state-of-the-art equipment, an orchestra pit, stage facilities, and a grand marquee. The main floor and the balcony had a total seating capacity for 1,200 persons. Today, the 1921 theatre stands vacant, and the marquee is long gone. In April 2021, the City condemned the building due to a fire that destroyed the roof and damaged the upper story of the front

section. A few months later, a nonprofit corporation acquired the building, with plans to rehabilitate and repurpose it as a multi-purpose venue. However, no progress has been made, and the City is moving forward with soliciting bids for demolishing the entire building. The theatre was added to the National Register of Historic Places in 2015. (On Endangered Buildings List since 2012)





## Historic Preservation Fund Grants



#### **SHPO HPF Grants**

- Between \$150,000 and \$200,000 distributed annually
- Eligible Applicants: cities, counties, non-profits
- 75% of funds reserved for CLGs
- 60/40 Match
- \$50,000 Individual award max
- 18-Month duration: Summer 2025-May. 2027




